Communications—*Susan Christenbury* commented that since the newsletter arrived in poor shape to many members, envelopes will be used again in the future for mailings. Consumer Education—*Dixie Elmes* reminded the group to be careful about the variety of scams to steal personal information—especially from phone calls, texts and emails. *Susan C.* commented that Google is a useful tool to search the validity of unknown addresses or phone numbers. *Dixie* also reported that Consumer Reports has a petition for the government to pass legislation to give total costs, instead of additional fees added to purchases, travel, tickets.

Old Business—*Bonnie* explained that *Laurie* has resigned her position, due to family health concerns/caregiving and other obligations. Although the group was thrilled when she agreed to serve as Recording Secretary, another volunteer replacement is now needed.

New Business—*Bonnie* shared forms for **MRSPA** dues deduction, including a special incentive to join for \$10 through July. State dues will be increased to \$50 this year, and county dues remain \$10. **CCRSPA** agreed to the **MRSPA** scholarship foundation donation of \$50 and \$25 for officers' insurance coverage.

MRSPA scholarship raffle tickets are available for purchase--\$10 each or 3 for \$25.

Zeenie Burns shared that the CCRSPA \$1,000 scholarship information is now online, open to anyone employed by CCPS. Application deadline is April 1. A proposal was made to include information in the upcoming newsletter to ask for individual donations towards the CCRSPA scholarship.
